

The Board is always looking for ways to improve our community's experience of Unicamp, so please reach out to the Executive Director if you would like to make suggestions.

On behalf of the Board of Directors, I would like to extend gratitude to the members of the Board who will or have stepped down: Doug Fyfe (treasurer), Lauren Renzetti (programs and seasonal campers), Anne Dahmer (administration), Anne Bokma (communications), Sky Dasey (interim seasonal campers), and Helen Iacovino (secretary). I would also like to thank all our volunteer working group members on the safety policy, finance, and property working groups. My gratitude also extends to all our staff, volunteers, members, and friends for being so generous with your time and your donations this year.

Now that Unicamp members and Board have decided to set a new fiscal year for Unicamp – adjusted by one month to run from December 1 through November 30 – in order to facilitate a more practical planning cycle for programs and finances, the coming cycle will be shorter than usual. With intentions for the 2025 Annual Meeting to be held in the spring, along with the departure of Unicamp's dear Executive Director, Yvette Salinas, we will likely require the incoming Board and committees to attend properly to fewer priorities and plans.



Welcome and Introduction

Unicamp Board President, Terri Marks, presided as Chair and welcomed delegates and all participants, and acknowledged the Board of Directors for their work.

Reverend Pat Trudeau offered the opening reading.

Executive Director, Yvette Salinas acknowledged Indigenous lands.

CUC ED Vyda Ng shared words of appreciation on the partnership between Unicamp and CUC.

Kalvin Drake gave instructions on Zoom features for voting and discussion.

The Chair offered a brief recap on Roberts Rules of Order. Questions were invited; none received.

Scruitineers were named as Yvette Salinas and Rebecca Mellett.

Quorum for the AGM was confirmed by Yvette Salinas (i.e., a minimum of 25% of the number of institutional members and 10 voting delegates).

Call to Order The AGM was called to order at 10:46am.

Appointment of the Parliamentarian & Scrutineer

Kalvin Drake was confirmed as Parliamentarian for the AGM.

Agenda: Motion to accept the meeting agenda for the AGM

The Chair called for any additions to the agenda. Two additional items were proposed:



- 1. Tanya Cothran: update on the assessment by Ontario Camps Association
- 2. Jim Lawry: update on Unicamp pricing and the pond.

Motion to amend the agenda:

Moved by Jim Lawry, seconded by Lauren Renzetti The additional agenda items were approved.

Motion to accept the agenda as amended:

Moved by Lauren Renzetti, seconded by Tanya Cothran The revised agenda was approved unanimously.

Minutes of 2022 AGM

Motion to amend the 2022 AGM Minutes to correct reference to The Unitarian Fellowship of North West Toronto (page 1): should be "Northwest".

Moved by Tanya Cothran, seconded by Nora Menzies The motion was carried unanimously.

Motion to approve the 2022 AGM Minutes as amended:

Moved by Lauren Renzetti, seconded by Tanya Cothran The 2022 AGM minutes were approved unanimously, as amended.

Treasurer's report

The Interim Treasurer, Rebecca Mellett, presented Unicamp's Financial Statements for the year ending December 31, 2022 as reported by GTA Accounting. A slide was presented to indicate an income of \$430,299 in revenues was received, and \$441,070 expenses were paid out, leaving a deficit of \$10,771. The Treasurer noted spending increases in several areas which are reflected in the deficit, including:

- Advertising costs of \$3,669 to improve branding, communications products
- Insurance fees increased by \$2,908 in order to extend coverage of the Camp Accident Benefits Package to volunteers
- Professional fees (accounting, lawyer) \$2,629 due to additional bookkeeping costs
- Food costs went up by \$5,202
- Salaries and wages increased by \$89,060 to hire more staff for safety and program quality

Referring to page 2 of the Unicamp Annual Report 2022-2023, the Treasurer noted that donations and grants had dropped by \$17,855 compared to 2021 because the Trillium Grant was not applied for. At the same time, "Other" revenues increased by \$33,992 due to a more complete program compared to the Pandemic era.



In terms of Unicamp's cash balances at the beginning and the end of the year, the following figures were shared to compare fiscal year (calendar) to operational year (AGM-AGM).

Time Period	Beginning of year	End of Year
Fiscal Year 2022 (Jan 1-Dec 31)	\$280,392	\$232,340
Operational Year 2022-23 (AGM-AGM)	\$134,633	\$176,713

Due to the fact that Unicamp has ended the year with a healthy cushion of cash for the coming year, the Board of Directors decided on October 19th to invest \$50,000 in a short-term GIC to gain better interest.

- Dave Renzetti noted the jump in staffing costs is a 50% increase, which is not sustainable.
 - Yvette Salinas explained that costs have increased post-COVID with additional programming, staff and food costs. The Board President added that additional staff are important for safety rules and procedures.
- Jim Lawry asked about the new GIC's term.
 - Treasurer explained that it will be a 6-month low penalty GIC, to make money on our money.
- Jennifer Bloom suggested that the meal plan could be more cost-efficient as a vegetarian or vegan base with meat and other protein options.
- Patricia Trudeau asked what is included in "Other" revenues of \$41,440.
 - Yvette Salinas responded that it represents interest income from investments and that this should feature under a different line item.
- Vyda Ng (CUC) noted that staff are very important to the proper functioning of Unicamp.
- Wilburn Hayden asked how the annual cash balance (surplus) should be used.
 - Treasurer: the incoming treasurer will lead budget planning. Unicamp has to balance trade-offs between paying staff a living wage and other expenses vs keeping costs low.
 - President: The Board is thinking long term, how government grants and other funding sources can meet immediate and long term expenses, capital cost.
- Wilburn Hayden said meat eaters and children want to keep meat options.
- Wanda Gordon added that in addition to the rising cost of food, more campers means more people to feed.
- David Renzetti noted that government grants are being used to keep Unicamp fees low: why should taxpayers subsidize Unicamp?
- President: self-sustaining is the objective, we do not want to be overly reliant on grants.
- Richard Bailey: what about allying with a farm to reduce food costs as other camps do?
 - Yvette Salinas: Unicamp must comply with food safety regulations.
 - Lauren Renzetti: in the past growing our own food would require more staff (4) and the growing season is very short.
 - Bee Bishop, former staff: labour costs to run a farm will not offset camp staff costs.
- Jim Lawry asked about savings through Costco and bulk shopping. Or bring back the Dream Auction.
- Jennifer Bloome: talked about eating meat vs vegan in regards to our UU principles.

Accountant's Financial Review Report & Financial Statements for 2022



Motion to accept the Financial Review and Financial Statements for 2022, prepared by GTA Accounting:

Moved by Richard Bailey, seconded by Jim Lawry The Financial Report was approved unanimously.

Recommendation to Audit Unicamp Finances for the 2023 Program Year

The Interim Treasurer recommended an audit for the 2023 fiscal year as it has been three years since the last audit, and this will support organizational strengthening while satisfying eligibility requirements of funders. She also noted that annual audits are the default required under ONCA (and not a review).

- Richard Bailey supports an audit.
- David Renzetti moved for a financial review, more cost effective.
- Yvette Salinas clarified that the estimated cost of an audit is \$7k (2021). compared to \$4.5K for a financial Review (2022).
- Anne Dahmer added that audits are important to be a professionally-run charity to put a stamp of approval on our organization as worth investing in.
- Kalvin Drake clarified that ONCA allows financial reviews instead of an audit as an option only for charities with revenue between \$100-\$500K.

Motion to undertake a financial review instead of an audit:

Moved by David Renzetti, seconded by Jim Lawry The motion was defeated.

Motion to appoint GTA Accounting to undertake Unicamp's audit

Based on the vote above, Unicamp will proceed with an audit of its 2023 operations.

The Interim Treasurer mentioned that it is good practice to switch accountants every five to six years, and that Unicamp has commissioned GTA since 2018. She is comfortable recommending GTA as Unicamp's accountant for 2023-2024 as they know the books, and can be an efficient auditor.

Motion to proceed with GTA Accounting as Unicamp's accountant and auditor for 2023-2024:

Moved by Richard Bailey, seconded by Jim Lawry

The motion was approved.



Nominating Committee Report & further nominations from the floor

Elizabeth Gray thanked the Nominating Committee and explained that the search and selection process includes demonstrating a commitment to UU Principles and seeking a diverse set of skills. The following directors will be continuing their roles in 2023 - 2024 on the Board to complete their 2-year terms:

Terri Marks, First Unitarian Congregation of Toronto (currently serving as President)

Helen Iacovino, First Unitarian Congregation of Toronto (currently serving as Secretary)

Anne Bokma, The First Unitarian Church of Hamilton (currently serving as Communications Chair)

Rebecca Mellett, First Unitarian Cong of Victoria B.C. (currently serving as Long Range Planning Chair and Interim Treasurer)

Lauren McKinley Renzetti, Neighbourhood Unitarian Universalist Congregation (currently serving as Program and Seasonal Chair)

The nominating committee is working to confirm a candidate for the youth representative role.

Nominees for the Unicamp Board of Directors for the 2023 – 2025 term are:

Anne Dahmer, Grand River Unitarian Congregation Terry O'Sullivan, Unitarian Congregation of Guelph Dianne Heise, Grand River Unitarian Congregation Doug Fyfe, Grand River Unitarian Congregation

On behalf of the UU and Unicamp communities, the Nominating Committee thanked the Directors who are completing their terms on the Board for their service and important contributions to the Unicamp community.

Special Resolution on Number of Directors

Kalvin Drake explained that "As Unicamp's governing documents allow for a range in the number of directors (up to 9), under ONCA, the actual number of directors on the Board (and, therefore, the number of directors to be elected at the AGM), must be established by a special resolution". That number will stay in effect until changed by another special resolution at a subsequent AGM or special meeting.

Jim Lawry asked if Terry O'Sullivan can be on the Board. The Board President confirmed that he is eligible because he is not an employee of Unicamp.

Special Resolution to set the number of Directors on the Board to nine (9):

Moved by Tanya Cothran, seconded by Vyda Ng.

The motion was approved unanimously.



Election of the Board of Directors 2023-2025

The Board President called for nominations from the floor. There were no new nominees.

Motion to acclaim the four new Directors:

Moved by Jim Lawry, seconded by Lauren Renzetti The Directors were approved.

Election of the Nominating Committee 2023-2024

The President explained the importance of the Nominating Committee to recruit new Board members to lead Unicamp, keeping in mind the diverse sets of skills required. This is a 1-year assignment for four (4) people from different congregations (including one Board member).

Two volunteers came forward: Ed Bennett (Grand River Unitarian Congregation), Winnie Larsen (First Unitarian Congregation of Toronto)

Motion to elect Ed Bennett and Winnie Larson to the Board Nominating Committee for 2023-2024: Moved by Lauren Renzetti, seconded by Nora Menzies.

The nominees were elected.

New Business

1. Update on the assessment of Unicamp by Ontario Camps Association

Unicamp's Board approved the funds (\$400) to initiate an assessment for accreditation by the Ontario Camps Association. The Executive Director and Camp Director are presently reviewing the application instructions and preparing materials to apply for assessment. This is an extensive 2-year process, including policy documents, organizational references and site visits. Year 1 is the assessment, with guidance from OCA, and Year 2 confirms implementation of improvements.

- Tanya Cothran noted that the Board of Toronto First is pleased that Unicamp is undertaking this third-party review, particularly to address concerns about safety.
- Jim Lawry asked if the review will look at dorms?
 - Yvette Salinas confirmed that yes the facilities are included, although the focus is mostly on kids and youth programs.
 - o President added that this will benefit family camp as well.
- Wilburn Hayden asked how adding Unicamp to the list of OCA accredited camps could change Unicamp?



- Yvette Salinas confirmed that the nature of Unicamp will not change (still UU).
- 2. Update on the pond and Unicamp pricing.
 - Jim Lawry asked whether the pond was fixed permanently, or will this be a recurring issue.
 - President: people are no longer allowed to dive off the tower.
 - Property Manager, Luc Lepage: condition of 60-year old pond boards were poor, so were replaced.
 Assuming a 25-year maintenance cycle. The tower concrete base and parging was repaired, with new boards to protect from ice during the winter.
 - Jim asked how Unicamp pricing will remain affordable, thinking of seniors for example.
 - Yvette Salinas: a restricted donation "Campership Fund" allowed for discounts (25%) for kids (50%). The last cost update was in 2020/21.

3. Honouring Unicampers

Lauren Renzetti is thinking about ways to honour volunteers that have contributed so much to Unicamp over the years. She would like to reach out via newsletter on options and how we do that.

Jim Lawry is interested in working on this.

Motion to schedule next year's AGM 2024

An earlier date for the AGM will allow a better planning cycle so that budgets and plans can be completed by the end of the fiscal year (i.e. December).

IV. Highlights of Unicamp accomplishments 2023/2024

As this year's program is still underway, a more detailed report on programs and operations will be presented at the next AGM in the spring of 2025. Unicamp's 2023 program is outlined in the 2023 Annual Report which was presented last October, available here:

In the interim, what follows is a summary of what Unicamp has accomplished since October 2023:

Programs

- Registration: launched on time and ready in January
- Program design: improvements to camps for kids, youth and families based on participant suggestions
- Participant feedback: a new survey was created for children and youth camps, based on best practices at other camps, and the interests of Unicamp

Property

- A new Property Working Group was formed to oversee tasks and set priorities, see Terms of Reference here:
- Safety: removed trees, roots as tripping hazards
- Water outflow system: improvements of dam boards to ensure no future issue with too much water being released
- Water filtration: Diagnosed water filtration issues and made a short-term solution
- Accessibility: built ramps, bridges to housing structure
- Dorms: Repaired a dorm from animal damage, ensuring safety for children's campers
- Campsites: Assessed to understand why some are under utilized
- Generator: researched, purchased, and began installation of a generator to use in the Dining Hall in case of power outage to protect food from spoilage and ensure base activities can carry on.
- Energy: tested and improved power to accommodations and campsites to ensure compliance with the Electrical Standard Authority.
- Aesthetics: Continued camp beautification projects including better signage on cottages and improvements to the Admin buildings.

Finance

- using dual system of accrual <u>and</u> cash accounting systems for annual and monthly tracking and analysis, respectively, to comply with accountant advice (accrual) while maintaining monthly information to monitor and account for spending
- Financial guidance: a new Finance Working Group was created to support the Board and Management and is providing valuable assistance and expertise, Terms of Reference are available here
 - https://unicampofontario.ca/wp-content/uploads/2024/08/terms-of-reference.pdf Going forward, these are priorities for the incoming Board to consider:
 - → Open High Interest Account for Unicamp (\$50k) as instructed by Members at the 2023 AGM; 2 meetings were requested with Unicamp bank, TD, and their representatives did not show up both times. Alternate high-interest mechanisms



- will be explored as a priority to earn better interest on Unicamp's savings, without being penalized for access.
- → Fundraising assistance: establish a new Working Group and explore hiring an intern graduate student in not-for-profit management

Administration

- Online systems: improved registration and accommodation web platforms
- Admin roles and responsibilities: in response to changing systems and increased community needs, reworked admin structure and responsibilities which encourage collaboration
- Insurange: researched and negotiated new insurers for Unicamp property, volunteers and staff with Co-operators
- Service agreements: Negotiated and monitored

Communication

- Newsletters: Published 11 updates to keep Unicamp community informed and up-to-date, with emphasis on ensuring that Unicampers are aware of progress and status of Safety Action Plan, Property improvements, new membership model for Bylaws (single class of institutional members with voting rights) available here: https://unicampofontario.ca/newsletters/
- Social media: improved content to be more engaging, for example a series to promote the Celebration of 55 years of Unicamp

Governance

- Unicamp Bylaw revisions (see next section for details): the Bylaw Working Group met weekly to review and develop updates to Unicamp Bylaws to comply with the Ontario Not-for Profit Corporations Act (ONCA, 2010) in time for the province-wide submission deadline on October 18, 2024;

- → Unicamp charitable purposes: Investigating the legal process for updating our charitable purposes in the future, once by-laws and Article compliance with ONCA is completed. This follows the two year work of the Charter Committee and extensive community consultation on updating our purposes.
- → Unicamp Strategic Plan: an inclusive process is being developed for a multi-year plan for Unicamp. Unicamp appreciates the tremendous time and talent of its dedicated camp staff and volunteers to the Board, Working Groups and projects.

Without you, staff and volunteers, we would not be able to run Unicamp!





i. Unicamp Bylaw Revisions

Bylaws belong to Unicamp Members and the community. Among other things, Unicamp by-laws govern Unicamp's relationship with our members, how the Board works, and how we run our meetings. They are the basis for Unicamp's accountability and transparency. Besides addressing the requirements of ONCA, our review of the by-laws has focused on the expectations of our institutional members, i.e., UU congregations.

The Unicamp By-laws Review Committee was tasked with reviewing Unicamp's by-laws in response to recent legislative changes and to ensure they reflect the on-going needs of the organization. In 2021, there was a dramatic change to the legislation governing charities and other not-for-profits in Ontario when the *Ontario Not-for-Profit Corporations Act* came into effect.

Unicamp has until October 18, 2024 to review, update and file our "foundational documents" with the Ontario and Federal government, to be consistent with the new legislation. Unicamp's foundational documents are our Articles of Incorporation ("Articles", previously called "Letters Patent") and our by-laws.

→ Looking forward, a major component of Unicamp's Articles of Incorporation is our Statement of Charitable Purposes. The Unicamp Charter Review Committee had created an updated Statement of Charitable Purposes in 2022/2023, utilizing extensive Unicamp community feedback. The updating of Purposes will be an important consideration for members in 2024 and 2025 and is not part of the current proposed updates to our Articles.

<u>ii. Approval of Minutes of Special Meeting on September 21, 2024 to Ratify Bylaw and Article Amendments (ONCA compliance)</u>

Throughout the revision process, Unicamp's Board of Directors has been sharing the details of proposed changes to the by-laws and Articles so that Unicamp Members and community have an opportunity to learn about and discuss revisions to Bylaws and Articles of Incorporation (1969), such as:

Agenda: Motion to accept the meeting agenda

On a motion by Ed Langevin and seconded by Kendrew Pape, the agenda was approved.

Rebecca presented a brief overview of some of the more substantial proposed by-law revisions. There are also many, many minor editorial changes. Some of the proposed changes are to comply with ONCA (Ontario Not-for-Profit Corporations Act), some are on our lawyer's advice, and some are a matter of cleanup and housekeeping. All not-for-profits across Ontario are going through this process, and need to comply with ONCA by October 18, 2024. The changes include more appropriate and gender neutral language, as well as only one class of voting members, i.e. institutional membership for the congregations, and eliminating individual membership which was not really used and had no voting rights.

There are also changes to the Articles, formerly the Letters Patent, which date from 1969. Both resolutions being voted on at this meeting re. the Articles were written by our lawyer.

Some points raised by delegates:

- Under Nominating Committee (3.12b), proposal to say "re-appointment" instead of "re-election."
- Q: Why do we specify using Robert's Rules of Order (9.5) when these are exclusionary and may not be in accordance with our values?
 - An informal poll ("straw vote" was taken to see how widespread the concern about Robert's Rules was.
 - There was enough concern for the Board to take note of this.
 - The matter was tabled for discussion later, and it will be brought to a future AGM.
- Q: Is there a conflict of interest if a Board member who is a seasonal camper votes on setting the seasonal fees?
 - A: No, because when directors purchase programs it is not conflict of interest, according to ONCA, if they pay the same fees as others pay. We got legal advice on this, leading to good clarity around it. The Board will develop additional policies around this.
- Under 7.2 the Board is permitted to borrow up to \$50K at its discretion, in order to allow the Board to respond to a significant emergency such as a lawsuit or a fire. This is still a very large amount, and the Board has taken it under advisement to develop specific guidelines for such situations.

is hereby approved as provision of the by-law of the Corporation.

II. The board of directors of the Corporation is hereby authorized and directed to cause Section 2.1 as approved by this special resolution to be incorporated into and to form part of By-law Number 2024-01.

SPECIAL RESOLUTION OF THE MEMBERS OF

UNICAMP OF ONTARIO INCORPORATED

(the Corporation)

WHEREAS the Corporation was incorporated pursuant to the *Corporations Act* (Ontario) by letters patent dated February 10, 1969 (the **Letters Patent**);



AND WHEREAS the Corporation is now subject to the *Not-for-Profit Corporations Act, 2010* (Ontario) (the **Act**);

AND WHEREAS it is in the interest of the Corporation to make an application for articles of amendment pursuant to the *Act* to amend the Letters Patent.

NOW THEREFORE BE IT RESOLVED AS A SPECIAL RESOLUTION THAT:

- I. The Letters Patent be amended by:
 - 1. deleting therefrom in its entirety the clause that is designated by letter (b) on page 2 of the Letters Patent which reads
 - " (b) Subject to The Mortmain and Charitable Uses Act and The Charitable Gifts Act, to accept donations, gifts, legacies and bequests to maintain the foregoing objects;"

And replacing the foregoing deleted clause with the following:

- "(b) INTENTIONALLY DELETED;"
- 2. deleting therefrom in their entirety the clauses on page 3 which read as follows:

"AND IT IS HEREBY ORDAINED AND DECLARED THAT the Corporation shall be carried on without the purpose of gain for its members and any profits or other accretions to the Corporation shall be used in promoting its objects;"

"AND IT IS HEREBY FURTHER ORDAINED AND DECLARED that, upon the dissolution of the Corporation and after the payment of all debts and liabilities, its remaining property shall be distributed or disposed of to charitable organizations which carry on their work solely in Canada;"

"AND IT IS HEREBY FURTHER ORDAINED AND DECLARED that the Directors shall serve as such without remuneration, and no directors shall directly or indirectly receive any profit from his position as such; provided that a director may be paid reasonable expenses incurred by him in the performance of his duties."

- 3. By adding the following as new and additional special provisions:
 - "a. Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the corporation. No part of a corporation's profits or of its property or accretions to the value of the property may be distributed, directly or indirectly, to a member, a director or an officer of the corporation except in furtherance of its activities.
 - b. The corporation shall be subject to the Charities Accounting Act.



- c. No director shall receive remuneration for services provided in the capacity as a director, although they may be paid reasonable expenses incurred by them in the performance of their duties. Unless otherwise prohibited by the corporation, a director may be compensated for services other than as a director pursuant to the regulation made under the *Charities Accounting Act*, or with court approval or an order made under section 13 of the *Charities Accounting Act*.
- d. To invest the funds of the corporation pursuant to the *Trustee Act*.
- e. Subject to *Not-for-Profit Corporations Act, 2010*, (Ontario), upon the dissolution of the corporation and after satisfying the interests of its creditors in all its debts, obligations and liabilities, the remaining assets of the Corporation shall be assigned to The Canadian Unitarian Council, provided that at the time of dissolution The Canadian Unitarian Council is a registered charity and such property will only be used in furtherance of its objectives and purposes.
- f. All funds and other property held by the Corporation immediately before the articles become effective or that are received subsequently by the Corporation pursuant to any will, deed or other instrument made before the articles become effective, together with any income or other accretions to the funds or other property, will be applied only to the purposes of the Corporation as they were immediately before the articles become effective.
- g. The Corporation is authorized to establish and shall have one class of members. Each member of the class shall be represented by two (2) representatives and each such representative shall have one (1) vote on each question put to a vote of the members".
- II. BE IT FURTHER RESOLVED as a special resolution of the members of the Corporation that:
 - a) The change to the number of directors of the Corporation to range with a minimum of seven and a maximum of nine as set out in the Articles of Amendment are hereby approved.
 - b) The number of Directors shall be 9 provided the directors of the Corporation are hereinafter authorized to fix, by ordinary resolution of the board passed from time to time, the number of directors of the Corporation within the range of the minimum and maximum number of directors set out in the Articles of Amendment.
- III. The Corporation is hereby authorized to apply to the Ministry of Public and Business Service Delivery for the Province of Ontario, or, if applicable, any successor ministry or agency of the government of the Province of Ontario with jurisdiction (the **Approval Authority**), for the issuance of articles of amendment for the purpose of amending the Letters Patent in accordance with the provisions of paragraph I to IV of this special resolution (the **Articles of Amendment**).



IV. Any two directors or officers of the Corporation are authorized to execute an application for articles of amendment to be submitted to the Approval Authority, and to take any additional and ancillary action necessary to give effect to this resolution, including signing other documents and instruments, and approving such amendments to the application for articles of amendment as required by the Approval Authority in order for the articles of amendment to be issued.

- Having some kind of rules of order protects against hasty decisions and guides a Board or a meeting in cases of disagreement.
- The Executive Committee stated that it is committed to exploring other ways of running meetings and other rules of order, and to bring this forward for discussion at future meetings.



V. Changing Unicamp's Fiscal Year

For many years, Unicamp's fiscal year ran from January 1 through to December 31. The revised Unicamp bylaws, as above, sets a new fiscal cycle [December 1 through November 30] which will correct several challenges for operational, budget and planning cycles of UNICAMP, including:

- Annual Financial statements are not produced by our bank in time for Unicamp's
 accountants and management team to plan for the next season. Unicamp's accountants and
 Executive Director receive statements from the bank in mid- to late-January and generally
 report in February after verifying and reconciling income and expense statements with the
 Executive Director, bookkeeper and Treasurer.
- However, Unicamp's annual program planning takes place in November and December and into March in order to secure service contracts, prepare for staffing and inform campers about the upcoming season.
- An earlier year end aligns better with the seasonal and financial activities of the corporation.
- Changing the Fiscal Year to the end of November will allow financial records to be reconciled and adjusted earlier so that program plans and financial commitments for the next year can be put in place.
- In addition, ONCA regulations stipulate that "AGM to be held within 6 months of end of Fiscal Year". Changing the FY to end in November and scheduling AGMs before May will put UNICAMP in compliance with the law.





VI. Financial Report 2023

Unicamp's financial report for 2023 has been developed by the Board Director of Long Range Planning as Interim Treasurer, and the Board Vice President, with guidance of the Unicamp Financial Working Group which is greatly appreciated.

Recognizing the 10-month time lag on the audited financial report of Unicamp's 2023 operations, a contextual starting point is to note the closing bank balances of \$177,502.19 on October 1, 2024:

Chequing	\$ 89,587.94
Savings	\$ 87,914.25
Savings	\$177,502.19




Figure 1: Annual Cash Flow by Month from 2018-2023

Historically, this is higher than Unicamp's opening balances in October as the season ends and financial commitments are paid out by December as illustrated in Figure 1 below.

Unicamp's overall revenues increased in 2023 by \$74,569 due to:

- more campers returning in 2023, showing a recovery from Covid reductions with more income from programs and meals (\$48,111, and)accommodations (\$9,198)
- Similar patterns of greater income from Seasonal (\$10k) and occasional campers (\$7k) compared to the previous year

Yet, fewer donations and grants came in 2023, showing a drop in revenue of \$56,283 compared to 2022. This is largely due to the late surprise drop in Federal Jobs Grant by \$51k which left many not-for-profits across the province and country-wide struggling. The Auditors also noted a lagging impact of the loss of the additional \$20k revenue in 2022 from the forgiven loan under the Covid-era Canadian Emergency Business Account (CEBA). This shows up as an overall decrease in "Other" revenues by -\$16,384. For information, "Other" revenues also include: Merchandise sales (increased in 2023 from \$1k to \$2.5k), HST (up from \$7k to \$8k), and Event Rentals (up from \$12k to \$14k).



This leaves Unicamp's overall annual increase in revenues in 2023 compared to 2022 at a positive yet marginal \$4,551.

At the same time, Unicamp's overall **operating expenses in 2023** went up by \$45,539 compared to 2022 due to inflation and spending increases such as:

- greater costs for Programs and Food (\$32,022) due to more campers and inflation
- Professional fees (\$10,327) to pay for engineering fees and repairs to the water outflow structure in the pond and use of accounting services
- Salaries and benefits for more staff to run safe and near-full camps with annual increases to keep up with inflation (\$9,933)
- Repairs and maintenance (\$4,446)

These expenses are offset by the increased revenue and, to a great extent, with additional savings due to the lean financial management by the Executive Director with guidance from the Treasurer and Board. In 2023 there were reduced costs of:

- Operating costs of Office and bank charges (\$5,452 plus \$1,515 coded expense for an old donation)
- Advertising (-\$2,238)
- Insurance (\$2,003) due to negotiated rebates from a new insurance package with The Cooperators

Looking at the GTA **Audited Statement of Financial Position** (see audit page 1 with endnotes 2, 3) for the calendar year ending December 31, 2023, Unicamp's net assets decreased from 2022 to 2023 by \$51,759 which left an annual operating deficit for 2024. This is largely due to increased costs as outlined above, and includes the estimated amortization of the net book value

of buildings and facilities of \$4,5K.

The fact that Unicamp's year-to-year deficit grew to over \$51K in 2023 from -\$10K in 2022 is a significant concern and will continue to be managed closely by the Board and financial team.

Fortunately, the income from

indoor accommodations, camping and meals performed much better in 2023, as did programming for children and for adults, all of which helped to offset the reduced income from the youth summer jobs grant, and reduced donations.

Despite the strength of onsite activities, various expenses rose to a degree that they could not be covered by operational income. Across Canada, food price inflation rose significantly faster than overall inflation that year resulting in additional food costs. More staff were hired to ensure camp safety and program quality. Additional bookkeeping services increased our Professional fees, and emergency work on the Water Outflow system increased property expenses. Unicamp's Board is monitoring the balance between program costs and revenue options as part of long-term financial sustainability.

Going forward, Unicamp's Board of Directors, under the guidance of the Treasurer, Financial Working Group and as managed by the Executive Director, will continue to pay close attention to the financial health and sustainability of our organization. The incoming Board might consider prioritizing:

- → Increased fundraising, seeking of grants and the creation of a Fundraising portfolio of the Board
- → Analyzing costs of programs for children, youth, families, adults to ensure that Unicamp's fees are sufficient to cover costs while remaining affordable for participants
- → Developing a capital budget distinct from operations
- → Exploring new banking arrangements as the services and fees of Unicamp's Toronto Dominion Bank accounts are very high, and the TD staff has failed to attend three requested meetings to review and negotiate improved financial services (i.e. online banking with virtual two-step authorization, fewer costly fees as a not-for-profit instead of business rates)
- → Opening a high interest term deposit for Unicamp surplus as instructed by Members in October 2023. This would have been completed sooner if TD would have responded and attended requested meetings

iv. Financial Review vs. Audit

With the recent audit of Unicamp conducted for the last fiscal year, and given no concerns with Unicamp's financial administration, Unicamp's Board of Directors, as supported by its Financial Working Group, recommends an audit for the 2024 operational cycle.

The audit process is of value to Unicamp's financial management as it helps the organization to improve financial accounts, systems and processes. This will support ongoing organizational strengthening, while also satisfying eligibility requirements of funders. For information, annual audits are required under ONCA for organizations with revenue over \$500,000. Unicamp is approaching the cut-off for when an audit will be mandatory.

As Unicamp's revenue is still below \$500K, an alternative to having a full audit is to conduct a financial review for the year completed. While less onerous and thus less expensive, the methodology is not as thorough as an audit and may not be accepted by some funders. Should the members wish to entertain the proposal to have a Financial Review instead of an Audit,an "extraordinary motion" must be passed at this meeting. It will require an 80% majority to pass. Note that the Board is not recommending a financial review.

The accounting firm GTA Accounting has been commissioned since 2018 to review and audit Unicamp's financial statements (previously named as Edmunds Professional Corporation). Given their recent completion of the 2023 financial audit for Unicamp, for efficiency the Board is recommending to continue with GTA Accounting as Unicamp's accounting firm for the coming year.

→ Going forward, considering best practices for not-for-profits to occasionally move to new accounting firms in order to improve financial systems and analyses, Unicamp's Board of Directors and management team will assess options for selecting a new accounting firm in 2025. - c) Subsequent to the meeting at which the nominating committee was elected, the committee will hold a meeting for the purpose of electing a chairperson.
